The use of web based educational resources has risen steadily over the last decade and are increasingly being used by teachers and schools across Queensland to improve student learning outcomes and improve community engagement.

Our school and teachers make decisions about the best technology to meet the needs of our students. Sometimes it is beneficial for students and parents to utilise services provided by third party web based providers.

Ithaca Creek State School wishes to utilise the third party web based service provider/s listed below to aid students learning and community engagement. For your student to use the service the teacher or office staff will need to register them as a user. Registering with these providers requires student personal information to be disclosed to the provider of the service.
