Student Dress Code

Ithaca Creek State School is a strict uniform school. We have the support of our Parents and Citizens' Association to promote 100% adherence to the uniform. Our student dress code consists of an agreed standard and items of clothing, which includes a school uniform that Ithaca Creek State School students wear when:

- attending or representing their school;
- travelling to and from school; and
- engaging in school activities out of school hours.

The Ithaca Creek State School Parents and Citizens' Association supports a student dress code policy because it believes that a student dress code provides clothing that aims to contribute to a safe and supportive teaching and learning environment through:

- ready identification of students and non-students at school;
- fostering a sense of belonging; and
- developing mutual respect among students by minimising visible evidence of economic or social differences.
- promotes an effective teaching and learning environment by eliminating the distraction of competition in dress and fashion at the school

The Ithaca Creek State School student dress code reflects school community standards and is consistent with occupational health and safety and anti-discrimination legislation.

If there is a specific medical or religious reason that requires an adjustment to this code, permission must be sought in writing from the Principal.

We will actively encourage our students to take pride in themselves and their school. One way in which this may be achieved is through adherence to the school's dress standards. As the parent/carer and provider of your child, we seek your support in this matter.

Inappropriate dress refers to clothing or apparel worn by students that is deemed to be:

- offensive;
- likely to disrupt, or negatively influence normal school operations;
- unsafe for student or others; and
- likely to result in a risk to health and safety of student or others.

In circumstances where inappropriate or unreasonable dress is worn, appropriate action will be taken.

Parents are asked to ensure that ALL articles of clothing whether part of a school uniform or not, are clearly marked with the student's name.

Parents/Caregivers can be notified by letter that their child is not complying with the Student Dress Code.

Students not wearing swimming caps will be ineligible to participate in swimming.
Jewellery	<p>The following items are acceptable additions to the school uniform: earrings (sleepers or studs only), watch, religious insignia, medical alert</p>	<ul style="list-style-type: none"> A student wearing other jewellery will be asked to remove the item and if necessary give it to the teacher or take it to the office for safe-keeping for the remainder of the day.
Nail Polish	<p>Only clear nail polish can be worn</p>	<ul style="list-style-type: none"> Students wearing coloured nail polish will be asked to remove it by the next day.
Hair	<p>Shoulder length or longer should be tied back. Hair accessories should be maroon, gold or white. Gel may be used sparingly.</p>	<ul style="list-style-type: none"> Students will be encouraged to tie back long hair.
Helmets	<p>Helmets must be securely fastened. Non-wearing of helmets is against the law and is 'unsafe for the student and others'.</p>	<ul style="list-style-type: none"> If necessary the police will be contacted if reminders have not had effect.
Free Dress wear	<p>On school approved free dress days, students are required to wear clothing that is sun-safe and appropriate for the day to day activities at school. This would include closed in footwear.</p>
